Please mark your calendars now as this will be an "All Hands On Deck" weekend for the kennel club.

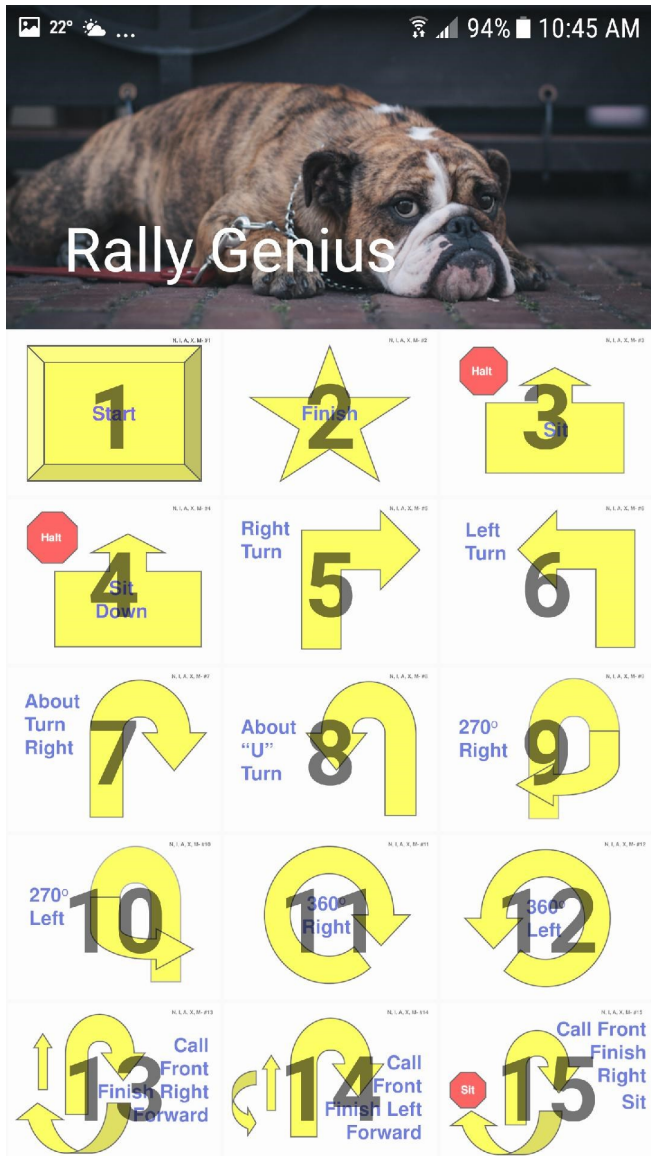

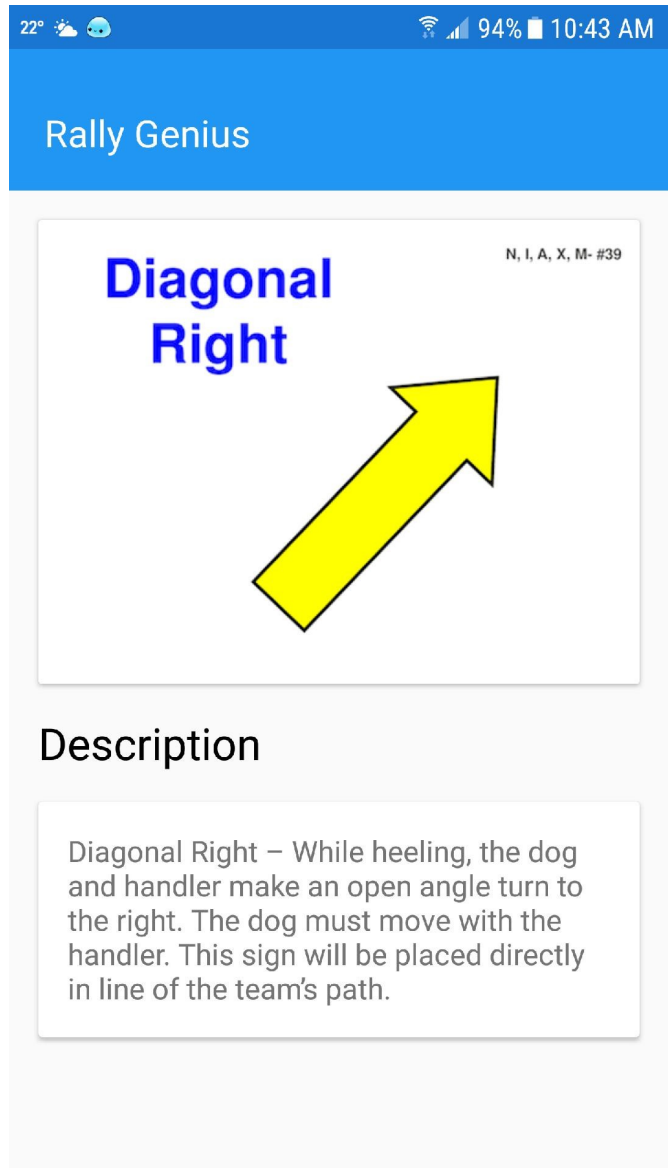
Tech Corner

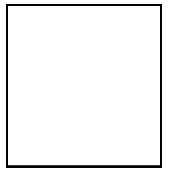
